Large Vendor

April 9-11, 2010

This document will serve as a contract between Thunder Run VI (event organizer and vendor),

The event organizer agrees to provide the vendor with booth space at Thunder Run VI.

The vendor agrees to provide the following:

Indemnity: Vendor agrees to indemnify, defend and save harmless , Inc. from and against all claims, demands, judgement, defense costs, or suites (including, but not limited to, claim, demands, judgments or suites for property damage, bodily injury, illness, disease, death or for loss of services, or wages or for loss of consortium or society) by vendor or its subcontractors or any employees of contractor or its subcontractors in any way, directly or indirectly, arising out of or related to the performance of the vendor in conjunction with this contract and any premise owned, operated, chartered, or controlled by IMOC, Inc.

Provide a Certificate of Insurance reflecting general liability, product liability, worker's comp, and liquor liability (if applicable). The minimum limit of coverage should be \$1,000,000.

Certificate Holder is I.M.O.C., Inc. 900 W. Memorial Road, Oklahoma City, Oklahoma 73114.

Signed Contract: Vendor shall release I.M.O.C., Inc. of any liability for, and shall protect, defend and indemnify I.M.O.C. from and against all claims, demands and causes of action of every kind and character, without limit and without regard to the cause or causes thereof or the negligence of any party or parties, arising in connection herewith in favor of vendor's employees or vendor's indemnity under this contract shall be without regard to and without any right to contribution from any insurance maintained by the vendor.

Vendor must provide their own extension cord. Food vendor must provide their own water hose.
